

Terms and conditions of participation in the competition "Buy a Lent ticket and win an E-scooter!"

1 Organizer of the competition

These rules determine the manner of hosting and organizing the competition "*Buy a Lent ticket and win an E-scooter!*" (hereinafter referred to as competition), organized by the Cultural and Event Center Narodni dom Maribor, Ulica Kneza Koclja 9, 2000 Maribor; company registration number: 5650437 (hereinafter referred to as the organizer), in cooperation with the sponsor E prihodnost d.o.o., Črešnjevi vrh 17, 2313 Fram.

2 The purpose of the competition

Informing the visitors of Lent Festival about electric mobility projects and presenting an award to one of the Lent ticket owners.

Lent ticket is a **basic festival ticket** for all venues. It allows customers to buy tickets for selected festival events, marked with (entrance), **with discount**.

3 Duration of the competition

The competition will be held from June 17 to July 6, 2013.

4 Prizes and awarding prizes

The organizer will select one of the ticket owners with a draw. The winner will receive an ELECTRIC SCOOTER TOMOS E lite.

The prize draw will take place on Saturday, July 6, 2013, at the Central stage at the Drava river before the beginning of the concert at 21.30.

The prize will be subjected to tax in accordance with the Personal Income Tax Act. The prepayment of income taxes will be deducted by the competition organizer. The listed gross income will be included in the annual tax base (i.e. when assessing the personal income tax).

Prizes are non-transferable and there is no cash or prize alternative.

5 Conditions for participation in the competition

To qualify to enter the competition you must purchase a Lent ticket online or at points of sale, namely Info office of Narodni dom Maribor or points of sale at festival venues.

All tickets owners must fill out the coupon. It is considered all contestants agree with the terms and the conditions of the competition.

More than one entry per person is allowed, which means participants can buy several Lent tickets and fill out several coupons.

Lent ticket owners must submit their coupons to the boxes at the festival points of sale by July 6, 2013 at 8 PM at the latest.

The organizer does not accept any responsibility for potential damage, loss or injury that might occur as a result of the utilization the prize.

6 Other competition rules

The organizer reserves the right not to award prizes in the event that:

- there is a reasonable doubt whether the information submitted by participant is true, current and complete or
- the winner does not fulfill the conditions set out in these rules or they participated in the competition contrary to the rules and conditions of the contest or were not selected according to those rules, or
- the winner and alternate winners fail to claim the prize in accordance with the terms and conditions of the competition.

7 Document draw

The draw will take place at the Central stage at the Drava river and will be conducted by a committee composed of three members: two employees of the organizer and a representative of the sponsor. The draw will be public. The organizer will also draw three alternate winners that can claim the prize in the event that the winner does not claim the prize within one month from the notification or does not respond to the notification. In this case, the award can be claimed by the alternate winner.

The organizer of the competition will keep a record containing the information about the date, time and place of the draw, persons present, course of the draw and all winners in the order in which they will be drawn (winner and three alternate winners). The minutes will be signed by all members of the committee and the printed version will be kept by the organizer of the contest.

The draw is final and not open to appeal. The organizer does not accept any responsibility for incorrect or illegible information. The winners will be notified by mail to the address listed on the coupon in ten days from the date of the draw at the latest. The organizer will state all additional information about the time, place and manner of claiming the prize.

The participant that will receive the award is liable to pay income tax in accordance with the tax regulations and is obliged to provide information about their tax identification number. Within 20 days of receipt of notification, the winner must send back their personal data (name, surname, date of birth, address, house number, postal code, city, e-mail address) and tax number. That indicates the winner wishes to claim the prize.

If the winner does not respond to the notification about the prize within the time allowed, it will be considered they disclaim the prize. In this case, the organizer is not obliged to give the prize and is

free of any obligations to the winner. The winner is not entitled to any other compensation. If none of the alternate winners claim the prize, the organizer has the right to use the prize for other purposes.

The duty of charging and paying the prepayment of income tax on the value of the prize is charged to the organizer. Organizer will deduct the prepayment of income taxes of the value of the prize in accordance with applicable regulations. Any additional payment of income tax in accordance with the decision on personal income tax assessment will be charged to the winner. The organizer reserves the right to request a copy of the identity document and tax identification number of the winner in order to ensure the information is correct.

The prize will be subjected to tax in accordance with the Personal Income Tax Act. The prepayment of income taxes will be deducted by the competition organizer. The listed gross income will be included in the annual tax base (i.e. when assessing the personal income tax).

8 The results of the draw

The final outcome of the competition and the winners will be published at the website of the organizer. The organizer has the right to use the names, surnames and addresses of the winners publicly for the purposes of competition.

Only natural person are eligible to enter the competition. Employees of the organizer and their immediate families (spouse or person with whom the employees live in cohabitation, which is, according to the regulations on marriage and family relations, equal to marriage, children or adopted children, grandchildren, siblings and parents or adoptive parents of the employee), and all legal and natural persons connected with the competition or employees of any associated companies are not eligible to enter the competition.

9 Participation in the competition and the protection of personal data

By entering the competition the participants allow the organizer to collect, process, and store their personal information. The organizer is obliged to distribute the information in accordance with the Personal Data Protection Act. Any personal data relating to entrants will not be disclosed to a third party or used otherwise without the individual's consent. The organizer has the consent to use this data for other purposes of the informing about the competition in accordance with the Personal Data Protection Act.

Participants in the competition are entitled to request access, copy, update, correction, blocking or deletion of their personal data or suspension of the processing of their personal data for the purposes of this contest, in accordance with the Personal Data Protection Act. The organizer reserves the right to change the terms and conditions of the competitions. The participants will be informed about all changes in an appropriate manner and place.
